

*The definitive Treaty of Peace and Friendship between her Britannic Majesty, and His Serene Highness the Grand Duke of Elsanor. Concluded at Pensacola the 13th day of January, in the Year of Our Lord 2005.*

In the Name of the Most Holy and Undivided Trinity, Father, Son, and Holy Ghost. So be it.

Be it known to all those whom it shall, or may, in any manner, belong,

It has pleased the Most High to diffuse the spirit of union and concord among the Princes, whose divisions had spread troubles in the four parts of the world, and to inspire them with the inclination to cause the comforts of peace to succeed to the misfortunes of the recent past, which having arisen between British West Florida and the Grand Duchy of Elsanor during the reign of the Most Serene and Most Potent Queen, Elizabeth the Second, by the grace of God, Queen of Great Britain; and the Most Serene and Most Potent Duke, Eric the First, by the grace of God, Grand Duke of Elsanor. For this purpose, the high contracting parties have named and appointed their respective Ambassadors Extraordinary and Ministers Plenipotentiary, Who, after having duly communicated to each other their full powers, in good form, copies whereof are transcribed at the end of the present treaty of peace, have agreed upon the articles, the tenor of which is as follows:

Article I. There shall be a Christian, universal, and perpetual peace, as well by sea as by land, and a sincere and constant friendship shall be re established between their Britannic, and Most Faithful Majesties, and between their heirs and successors, kingdoms, dominions, provinces, countries, subjects, and vassals, of what quality or condition soever they be, without exception of places or of persons: So that the high contracting parties shall give the greatest attention to maintain between themselves and their said dominions and subjects this reciprocal friendship and correspondence, without permitting, on either side, any kind of hostilities, by sea or by land, to be committed from henceforth, for any cause, or under any pretence whatsoever, and every thing shall be carefully avoided which might hereafter prejudice the union happily reestablished, applying themselves, on the contrary, on every occasion, to procure for each other whatever may contribute to their mutual glory, interests, and advantages, without giving any assistance or protection, directly or indirectly, to those who would cause any prejudice to either of the high contracting parties: there shall be a general oblivion of every thing that may have been done or committed before or since the commencement of the Troubles which is just ended.

Article II. The Britannic Majesty, and Her Governor-General in the Dominion of British West Florida do hereby Specifically, and without Prejudice Recognize and Affirm His Serene Highness' Claim to the lands known as Pelican Island, Sand Island, Petit Bois Island. Her Britannic Majesty also notes the Claims made by His Serene Highness for Territories Beyond the Northern Border of the Dominion of British West Florida.

Article III. The Serene Highness and his Court do hereby Specifically, and without Prejudice Recognize and Affirm Her Britannic Majesty's Claim to the other lands known as the Dominion of British West Florida. His Serene Highness Recognizes and Affirms the Right and Legitimate Government of Her Majesty's Governor-General in British West Florida, Robert, Duke of Florida.

Article IV The Britannic Majesty directs that Her Governor-General Establish and Support the Serene Highness of Elsanor as Earl of Rum, and Lord of Baldwin and Jackson.

Article V Her Britannic Majesty also Notices and Supports the Claims made by His Serene Highness to Territories Beyond the Northern Border of the Dominion of British West Florida.
